

NOTICE TO BIDDERS

1.01 PROJECT INFORMATION

- A. Notice to Bidders: Qualified bidders may submit construction bids for the Project described in this Document. Submit bids according to the Instructions to Bidders (AIA Document A701-2018) and Supplementary Instructions to Bidders (Section 002213).

- C. Project Description: Work of the project includes the construction of a 5,300 square foot masonry addition. The addition will consist of a commercial kitchen serving the entire district as well as a new high school science room. Renovations to the existing kitchen and commons will be included as part of the base bid. Several alternates shall be considered for the project including renovations for a new concession stand and renovations to the existing Family and Consumer Science classroom. See Section 012100 for full list of Alternates.
 - 1. Project cost is anticipated to be under Three Million, Four Hundred Thousand dollars (\$3,400,000.00).
- D. Construction Contract: single bid will be received for the work of the General Contractor including the work of all subcontractors. Subcontractors of all construction trades shall submit bids to the General Contractors.

1.02 BID SUBMITTAL AND OPENING

- A. All sealed lump sum bids prepared in compliance with the Instructions to Bidders must be received by the Riceville Community School District at the location and by the time noted below. Bids will then be publicly opened and read aloud.
 - 1. Bids Due:
 - a. Time and Date: 10:00 AM local time on Tuesday, July 2, 2024.
 - b. Location: Riceville CSD District Office, located at 912 Woodland Ave, Riceville, IA50466.

1.03 BID SECURITY

- A. Bid security shall be submitted with each bid in an amount not less than five percent (5%) of the bid amount. No bid may be withdrawn for a period of 60 calendar days following the date of the opening of bids. The Owner reserves the right to reject any and all bids, re-advertise for new bids, and to waive informalities and irregularities in the bids submitted.
- B. Refer to other bidding requirements described in AIA Document A701-2018 INSTRUCTIONS TO BIDDERS and Section 002213 - SUPPLEMENTARY INSTRUCTIONS TO BIDDERS.

1.04 BIDDER'S QUALIFICATIONS

- A. Bidders must be properly licensed under the laws governing their respective trades and be able to obtain insurance and bonds required for the work.

1.05 PREBID MEETING

- A. A Prebid meeting for all bidders will be held at the Riceville CSD Board Room, located at 912 Woodland Ave, Riceville, Iowa on June 18, 2024 at 10:00 AM local time. Prospective prime bidders are requested to attend.
 - 1. Bidders' Questions: Architect will provide responses at Prebid conference to bidders' questions received up to 48 hours prior to conference.

1.06 PUBLIC HEARING

- A. A Public Hearing will be conducted on the proposed plans, specifications, form of contract, and estimate of cost for the construction of the above-described project at the Riceville CSD Board Room, located at 912 Woodland Ave, Riceville, Iowa on Monday, June 17, 2024 at 6:25 PM.

1.07 BID AWARD

- A. The contract shall be awarded to the lowest responsible bidder whose bid is in conformance to the Bidding Documents prepared by Emergent Architecture. Bids may be held by the Owner for a period not to exceed sixty (60) days from the date of the opening to review the bids and investigate the qualifications of bidders. Once approved, a Notice to Proceed will be issued to notify the bidder of the contract award.
- B. By statutory authority, a preference shall be given to products and provisions grown and coal produced within the State of Iowa. And preference shall be given to local domestic labor in the construction of the improvement.

1.08 TIME OF COMPLETION

- A. Successful bidder shall begin the work upon contract execution and shall complete all work on or before August 1, 2025.

1.09 PERFORMANCE & PAYMENT BONDS

- A. The successful bidder will be required to furnish a Performance Bond and a Payment Bond within ten (10) days after award in an amount equal to one hundred percent (100%) of the contract price.

1.10 SALES TAX EXEMPTION CERTIFICATES

- A. Contractors and approved subcontractors will be provided a Sales Tax Exemption Certificate to purchase building materials and/or supplies required in the performance of the construction contract.

1.11 PRE-CONSTRUCTION CONFERENCE

- A. Before the work is commenced, a conference shall be held to discuss the contract. The conference shall be attended by the General Contractor, Subcontractors, Owner's Representatives, Architect and Engineers.

1.12 PROCUREMENT AND CONTRACTING DOCUMENTS

- A. Printed Documents: Obtain after June 5, 2024, by contacting Rapids Reproductions at 800.383.1223.
 - 1. Deposit: \$200.00 per set with a check made payable to Riceville Community School District. Deposits are fully refundable if the Plans and Specifications are returned in usable condition (i.e. generally free of markings, tears, soiling, etc.) to Rapids Reproductions within 14 days of project award.
 - 2. Shipping: Additional, non-refundable shipping charges of \$30.00 per set will apply to shipped documents. Provide a separate check made payable to Riceville Community School District.
